Planning & Development

- There have been some inquiries to the Township regarding work occurring on the Kehoe Marine site. Approvals have been obtained from Department of Fisheries and Oceans, the Ministry of Natural Resources, and the Cataraqui Conservation Authority. Staff have reached out to Kehoe Marine to get more information about the work occurring at the property and been provided with the following summary.
- Permits have been obtained for a fisheries compensation area in the bay, an area to be infilled, and new sheet pile wall.
- The work currently occurring in the shallow area closest to the road on the East side is the fisheries compensation area required by DFO. This work includes the following:
 - Dredge out the channels and areas for planting (this required temporary roads to access the areas with Excavator)

Planning & Development Cont'd

• Hand plant all the special plants when the weather is warm

- The dredging work should be completed in the next few weeks with planting in May or June depending on the weather. There will be infilling along the new wall area before the March spawning deadline with additional infilling after July 15th to complete the infill work and new sheet pile.
