Fire

Fire Services

- Fire Services responded to 5 calls for Service. 1 Fire (vehicle), 3 MVC's, 1 Medical.
- District Chief North completed and distributed Internal Training Schedule for first half of 2023 January 1 June 30.
- Preparations for Recruitment underway Deadline will be December 31st for applicants in order to begin a Recruit Class / Firefighter I, for January 31st 2023. Will be posted on Monday, November 21st.
- BLS and First Aid Courses arranged for December and January 46 members signed up. Full First Aid Course also scheduled for May 26-28 Mostly for new recruits, but also for anyone who misses these scheduled winter classes.

Regional Training Center

- Completed Courtroom Procedures Course early due to last minute cancellations of a few students 6 Completed the Course November 13th.
- Paperwork, kitchen, and classroom preparations completed for Driver Training Z Endorsement Course scheduled November 19-20, 2022. 10 Student enrolled.
- Training Center Programs Coordinator met with Front of Yonge Nov 17th to discuss training options and availability for 2023. Moving forward with FFI in first quarter, HazMat in the fall.
- South Stormont confirmed first of 2 classes in spring 2023 for FFI.
- Leeds curriculum developed for Basement Fire Suppression Tactics Dry run of course completed internally over 2 training dates. This assists with development of future programming and capacity at Training Center.
